# 1 - Rationale, Objectives, and Proposed Themes

We will refer to "manual tradition in craftsmanship" as the set of techniques and know-how passed down from generation to generation to produce utilitarian and/or decorative works. In Morocco, as elsewhere, these traditions reflect a unique vision and experience of the world within each local culture.

Today, these traditions cannot escape the global phenomenon of digitization, which represents the triumph of the discontinuous over the continuous, and the digital over the analog. How does this phenomenon impact traditional arts?

This symposium aims to examine the interactions between traditional arts and digital innovations, to recognize the positive or undesirable impacts of these innovations on contemporary artisanal practices, focusing on **the ornamental building arts** (Zellige, plaster, stone carving, and wood).

The theme of this symposium will be explored through the following five thematic axes:

Axis 1: History and Evolution of Moroccan Traditional Building Ornamentation

- Moroccan ornamental art from the 11th to the 21st century: Characteristics and influences
- Evolution of decoration techniques by material: Zellige, plaster, stone, marble, wood.

## Axis 2: Tradition Today

- · Attempts at definitions
- Tradition and cultural identity
- · Contemporaneity and modernity

## Axis 3: Craftsmanship, Sciences, and Technology

- · Materials: tradition and innovation
- Digital tools for design, modeling, and visualization of works (CAD; Computer-Aided Design, CAM; Computer-Aided Drafting)
- Digital tools for physical realization (laser cutting, CNC; Computer Numerical Control, plasma cutting, 2D and 3D printing...)
- Crystallography

## Axis 4: The Question of Patterns

- · Traditional techniques of geometric and floral tracing
- · Contemporary speculations on these techniques
- Algorithmic generation of "traditional" geometric patterns
- · Innovative proposals

# Axis 5: Impacts of Digitalization on Craftsmanship

### Positive impacts:

- New tools available to artisans and creators
- Acceleration and expansion of knowledge sharing
- o Digital marketing, social networks
- o Digital archiving

- Threats to traditional craftsmanship and heritage
- Spread of misinformation through social networks
- Mass production
- Dehumanization of artisan-client relationships

# 4 - Writing Standards

The article to be submitted to the Academy is a digital document composed of two files. The first file is a Word document with images and graphics inserted, and each figure should be indicated by the author as follows:

## Figure X

The figures should be accompanied by captions and numbered sequentially as **Figure 1**, **Figure 2**, **Figure 3**, etc.

The second file will be solely dedicated to the same images and graphics as the first file but presented in high definition, also accompanied by captions and numbered sequentially as **Figure 1**, **Figure 2**, **Figure 3**, etc.

Images should be in **JPEG/PNG** format with a resolution of **300 DPI** and in actual printing size (between a minimum of **A5** and a maximum of **A4**).

The author must ensure that any images used (photographs, diagrams, graphics) are not in violation of copyright.

#### **Article Presentation**

A summary of the article in a maximum of 15 lines, followed by keywords:

- Summary: This article...
- Keywords: ...
- Font: Times New Roman
- Text Size: 10
- Line Spacing: Single
- Justified Text
- The summary and keywords should have a 1 cm left indentation and a 1 cm right indentation.

An Introduction, the Body of the article, and a Conclusion should adhere to the following standards:

- Font: Times New Roman
- Text Size: 12
- Title Size: 14 or 16, depending on the importance of the title
- Line Spacing: 1.5
- Margins: Normal
- Justified Text

Different levels of headings within the body of the article should follow this sequence:

- Roman numerals, uppercase letters, numbers, and lowercase letters in italics:

I. II. III.

A. B. C.

1. 2. 3.

a. b. c.

Bibliographic References must be systematically presented as footnotes (using the automatic function in Word). These are all the bibliographic references cited in the text, including those consulted, even if they do not appear in the text.

All definitions, numbers or tables, quotations or information, thoughts or passages taken from a reference must be mentioned in footnotes. These footnotes should adhere to the following format:

- Font: Times New Roman

- Text Size: 10

- Line Spacing: Single

Justified Text

It should also be noted that:

Short quotations in the main text should be enclosed in French quotation marks exclusively (i.e., "quotation"). A quotation within a quotation should be enclosed in English quotation marks (i.e., "quotation within a quotation").

Quotations exceeding two lines should be indented by 1.5 cm from the text and should not be enclosed in quotation marks. These longer quotations should be written in a text size of 11.

Italicization is reserved for book titles, words or phrases of foreign origin to the language used for the article, and words the authors wish to emphasize.

Bibliography: This involves listing authors and their bibliographic references in alphabetical order and by category, adhering to the following format:

- Book: Author's Name, P. (2012), "Title of the Work," Publisher, City, page numbers.
- Journal Article: Author's Name, P. (2012), "Article Title," Journal Title, journal number and publication date, relevant pages.

- Thesis or Dissertation: Author's Name, "Thesis or Dissertation Title," type of thesis and discipline, University, Year.
